IV. INFORMATION FOR THE BOARD

Terrazzo Floors

At the April IDA Meeting, the IDA voted to not pay the repairs for the terrazzo floors at Ridgeview from the Ridgeview Construction Funds. The bid for the floor repairs was \$14,900. The reasons given by the IDA for their vote was that they believe that the school division should allocate funds from the Operation/Capital Project for these type of repairs. The School Board approved the repairs of the floors to be paid from the Ridgeview Construction account at its March meeting. The BOS had not yet voted.

As per Mr. Elswick, these repairs are not related to the maintenance or misuse of the building, but it was work that was under warranty for one year after the opening of the building. Since this is work that must be done when students are not in school, we were trying to schedule in April. Funds are available in the Ridgeview Construction accounts which will be discussed in more detail later in the agenda.

After consultation with Mr. Barton, funds cannot be committed to the repairs of the terrazzo floors at this time. The IDA and BOS were informed of the matter. Therefore this matter has been tabled for this year. I will keep you informed of this issue.

f. Update of the 2019-2020 State Budget

DCPS presented its budget request to the Board of Supervisors on Tuesday, April 2, 2019. Mrs. Mullins, Dr. Lyle, Phyllis Mullins, DEA President, Larry Barton and I were in attendance. We were informed by the Board of Supervisors that by Tuesday, May 14, 2019, we should receive notification of the appropriation request.

We shared with the Board of Supervisors that this year's budget includes a \$572,203 increase in state funds. We are also projecting an increase in Federal funding of \$229,000, and increase in County funding of \$500,000. The State Budget includes a 5% salary increase for employees with an appropriation of \$451,871. Estimated cost for salary scale revision is \$721,270.00.

Key points of the proposed DCPS FY 20 Budget are:

- 1. Revision of salary scales for all employees
- 2. Replacing all anticipated retirement positions
- 3. Proposed increase in salary scale for part-time employees
- 4. Purchase of two new buses
- 5. Hiring staff for Art/Music/Chorus at RHS and RMS; other essential instructional programs in K 12
- 6. Proposed 5% increase in health insurance premiums.
- 7. Capital Project Requests for Sewer and Roof at EES
- 8. Capital Project Requests for classroom fixtures, lockdown system, ceiling tiles at CES.
- 9. Using carryover Textbook funds to purchase Chromebooks for classroom and student use.
- 10. Replacing all anticipated retirement positions

g. Update on the New Elementary School

The Dickenson County School Board along with the Industrial Authority Board and the Board of Supervisors will meet for its mediation process as stated in the Facility Development Agreement on

Tuesday, April 30, 2019 at the Dickenson County Education and Research Center.

All three Boards will convene a Special Closed Called Meeting on Tuesday, April 30, 2019 at 9:00 a.m. and immediately go into Closed Session for the Mediation process. The three Boards will go to separate areas to meet with the Mediator. The mediation procedure will likely be a day long process.

By the end of the mediation process and with the assistance of the Mediator, hopefully, the three Boards will have reached a consensus on the school site.

h. Update on the DCPS Construction Budgets

In late March, Larry Barton and Curtis Elswick reconciled the Construction Accounts and determined the Working Project Budgets for Ridgeview and the new elementary school. Summary:

- A. June, 2016: Ridgeview Complex completely paid for. (Note burning took place June 2016)
- B. As of March, 2019, the local County contribution paid to the Corps directly for project is \$427,267.93 (This does not include the road to Ridgeview which was a partnership with VDOT).
- C. Budget Balance as of March, 2019: Ridgeview: \$540,113 (Minus Mitigation
 - 1. Cost for Spring Fork of \$275,000 = \$265,113.00
 - **\$389,654 from this account was used for the County's 5% Match for other 202 Projects.
 - 2. Financing: \$387,175
 - 3. Ridgeview and Financing: \$927,788
 - 4. Elementary School: \$24,434,528
 - ** \$210,346 from this account was used for the County's 5% match for other 202 Project
 - 5. Demolition: \$1,436,9206. Total: \$26,798,736.00

Of those top 10 largest occupations in the region, Career and Technical Education in Dickenson County offers programs, pathways, and training which supports 8 of the 10 occupations.

We hosted the first ever combined local and district CTE advisory committee meeting in March. We had approximately 60 people in attendance. Our teachers presented news and updates from their individual programs and shared numerous student accomplishments.

To mention a few:

Our nursing programs have earned full accreditation by the SBN. 100 percent pass rates for both LPN and CNA.

Continuing to explore options to offer the LPN/RN program in DC

Virginia Board of Barbers and Cosmetology approved program serving approximately 30 COS I students ASE certified auto mechanics technology and auto collision programs for 25 years; just received another 3 year accreditation; 100 percent pass rate on the ASE/ NATEF for completers

Added solar education to our Renewable energy course/pre-engineering classes-Through a grant from DMME-added solar panels to greenhouse. We are also in the process of adding a small solar array at RHS made possible through the Dominion Energy, the Dominion Energy Educational Foundation and the NEED project.

The agriculture program is thriving at RHS and has made many accomplishments. We are currently in the process of adding a hoop house at RHS and the plant growth is underway.

Some really cool things are happening in drafting including virtual reality, 30 printing, and exploration using drones.

We are very proud of our robotics team and their many accomplishments. Students are competing at the World Competition this week.

The marketing and Information Technology programs continue to prosper and excel in local and regional competitions and provide community support.

Our enrollment in Carpentry I and welding I classes have increased and those students are doing some really amazing things- Creativity at work.

Culinary Arts students participated in a 6 weeks "Eat Smart Move More", Virginia Family Nutrition Program sponsored by the Virginia Cooperative Extension.

We are on track to becoming a nationally recognized Blue Star school for financial literacy. We have added a Careers Investigation class to the middle school rotation.

Hosted Health Careers Expo for 8th grades -36 participants.

Middle school students participated in the first Energy Bowl competition. Continue have success with the middle school robotics team in competitions. We are building exploratory options at the middle school.

We have a very hard working and dedicated staff that continues to support our students. Our students are truly showcasing excellence.

I. Approval for an RFP for Health Insurance Carrier

We have been advised by our Insurance Consultant to submit an RFP for Health Insurance coverage for our employees for the 2019 – 2020 school year. As you recall, the School Board approved several significant modifications to the DCPS health insurance plan last year, which hopefully has helped the school division to reach its goal of significant savings in health insurance costs.

With these potential savings, DCPS is in a better situation to negotiate with health insurance companies for the same coverage as our employees now have but at a lower cost. We are advised that with the Board's approval of this RFP, the school division will have an opportunity to review options from a variety of health insurance companies to make the best decisions for our employees.

The timeline for the RFP is as follows:

- 1. Publish RFP: Thursday, April 25, 2019
- 2. RFP's due: May 22, 2019
- 3. Review from all Proposers
- 4. Recommendation to the School Board: June

The recommendation to the School Board in June may be to remain with The Health Plan, our current insurance carrier, or to move coverage to another insurance carrier.
