"August 2019: Enrollment and Attendance Report"

#### Be Great with 8! Be a Hero: Here, Every day, Ready, On-Time

The student enrollment on August 30, 2019 was 1979 and the overall monthly attendance percentage for August is 95.88%. Congratulations to all our schools!

Clintwood Elementary School won the Attendance Banner with 97.73% student attendance percentage, Ervinton Elementary School came in with a close second with 97.12% student attendance percentage. SES was third with 96.2% student attendance percentage.

#### f. Update on the New Elementary

Mr. Scott Mullins provided copies of briefs that were filed to give them a perspective of what happened at the hearing. "We had a hearing last week and I think that both sides are pleased that the hearing itself was very professional and collegial. The witnesses on both sides were very credible and I think Judge Patton got a very accurate rendition of what is at stake. There are really not facts in dispute but how we are going to move forward."

We have three issues that are irrefutable harm: the most catastrophic is that we are losing \$85,000 per month and our ability to build a school in every month that we delay. The other is that we could lose it all and I have minutes where Rebecca Bennett, Project Manager for the Corps of Engineers, says you need to start now. If we have a problem all this money can be diverted to someplace else. When we had our mediation that was the thing that Judge Gamble stressed; you need to act or you could lose it all. The third thing that kind of gets lost in all this is all the time we spend in delay is children remain in harm's way and they are not getting all the benefits that a modern school would provide them.

I anticipate that next week on Wednesday or Thursday Judge Patton will have all the documents in his hands and it will then be up to him to make a decision.

You have previously voted to study two sites and after Public Comment you may be compelled to make a motion to move this forward. But, this is what I have to say to that is first, Freedom of Information Act says the things we put on our agenda are the things we can vote on and that's not really on the agenda. Also, if you vote to consolidate the schools there are certain procedural requirements you have to comply with as far as Public Hearing. As much as you probably would like to do that, that's probably not appropriate for you to do.

#### h. DMME's Energy Performance Contract for Solar Energy at Ridgeveiw

Larry Barton, Denechia Edwards, Scott Mullins and Superintendent Robinson had the opportunity to meet with Charlie Barksdale, Utilities and Performance Contracting Manager, and Nick Polier, Energy Marketing Specialist with the Division of Mine, Minerals and Energy (DMME) to discuss DMME's new program to determine if an energy performance contract for solar energy would be an efficient method to explore for the Ridgeview Campus.

The goal of this motion is to study options for solar energy at Ridgeview through an energy performance contract. The School Board's approval would provide for the study. There is no additional costs to the school division for this study. The study would be finalized, and representatives from DMME would present the findings and potential savings of solar energy to the School Board at future meetings. #### VI. BOARD COMMENT

Dr. Lurton Lyle

- I attended the Willis district debate, Kennedy district debate and Clintwood district debate and there appears to be some media misrepresentation and even falsehoods. I have some facts to back up some of the things I have said that were indicated previously. The three main things I can think of right now is the salary of the Superintendent, the health benefits of the Superintendent and the cost of insurance in comparison with the Board of Supervisors; the cost to the division. As I pointed out in my talk, our Superintendent is the lowest paid Superintendent in Region VII, which is our region, nineteen divisions and two cities. She has a longer term experience; she is third in the length of experience. The average experience in our region is 4.29 years and she has 10 plus. I would say that she is responsible for more good news than anyone in our region possibly the State.
- On the stage I was asked what I thought of the Superintendent's salary should be and I said \$120,000. I'm only one Board member and that is a School Board decision. The average salary of the 19 Superintendents in Region VII is \$118,000 so my thought was not too far off the average and the average year of service is a little over 4 years. Due to term, due to the success we've had and due to the pay schedule of the region; it seems logical to me.
- Now the health benefits, I think the reason that came about was we, at that time, did not
  have enough money to pay what we thought should be paid so we used the insurance
  policy; that could be the family plan that everyone gets to get on or the delayed plan
  similar to a delayed compensation plan. That seemed logical at that time.

- During the three times that Mrs. Robinson has received a contract extension; she has never received a salary increase. All the salary increased that she has received while she has been here have been mandated from the State for other people also.
- Insurance cost for the Board of Supervisors; it's a fact that the School Board has a lower premium than the County. Actually, if we had gone with the County's experience or cost it would be \$1 million more per year. We are fiscal sound with that.
- I think the social media is trying to control this election perhaps to change the makeup of the School Board and perhaps the Superintendent. That's my thoughts.

#### **Rick Mullins**

- I would like to reiterate all that Dr. Lyle and that I agree with him and to add.
- I asked Mr. Barton to get a little information on the annual budget comparison for the last 10 years. Sometimes I think it's good to look back where the media is saying that we have not saved the County any money. I wanted to be able to give some real hard facts.
- In 2008-2009 we have 408 full time employees; today we have 312 full time employees. Total school budget has a savings for the 2018-2019 year compared to the 2008-2019; we have saved taxpayers \$5,120,000. So that's the difference in the comparison.
- That is a lot of money when we look at the population as of today there are 14,782 people living in Dickenson County. So if we equate those savings as to what the percentages is per man, woman and child; Dickenson County School system has saved every man, woman and child in comparison \$346.36 in Dickenson County. I think that's really amazing to do what the system has been able to do. I think that's a good job by everyone that's been involved working together. My hat is off to everyone.

#### **Rocky Barton**

• For Region VII, to be the lowest percentage in the State for funding, for our scores to be the highest in the State; it's just unbelievable. Of course, we all can put more money to use, look at what we are doing with less. It's just amazing for Mr. Robinson to stand up in front of us and 5<sup>th</sup> grade was 2<sup>nd</sup> in the State; it's just unbelievable for Dickenson County to be 2<sup>nd</sup> in the State. You all do a great job and we appreciate it; our Teachers, our Superintendent, everybody. You all do great and it's unbelievable where we've come in 5 short years with these scores.

#### Susan Mullins

• If the State would give us the same amount per student as they give other parts of the State it would reduce the amount of local dollars necessary. That's the difference.

#### **Rocky Barton**

• I love sports and our football program is unreal; where we are today in just 5 short years. To be in arguably the most competitive conference in the State and have 5,000 fans

screaming. Friday night was probably the second biggest crowd we've had at Ridgeview, the Union game last year and then this one. I'm so proud of our kids, our organization, our band. They wore their uniforms and marched on the field and done the National Anthem; I was just proud.

We are doing some good things even if we are being dragged down on some bad things;
 we are doing good.

#### Shanghai Nickles

I really wanted to comment on what Mr. Hill had to say. There is a challenge up here. Mr.
Mullins are you telling us we can't make a motion on where we think the school should be
built at this time? Is that what you are telling me?

#### Scott Mullins

 Yes, I'm saying that as far as a motion. I'm not saying that anyone is censored in expressing their own opinion you just can't do it as an official motion because there are certain legal protocols in order to do that.

#### Shanghai Nickles

- I did look at the map and I realize what Don has put together has took a lot of time and has a lot of validity. Don, I wish we were able to do that but apparently it's something that we are not supposed to do.
- The other thing I'd like to mention is the Ridgeview High/Middle School was built for 1,400 kids and we're down to 1,100 kids in a little over 4 years. I don't know what it will be in the next 4 years; that's always a worry.
- As people in businesses in our area, I think the podcasting would be a great thing, but I think it's got to be doing with people who know what they're doing, when they're doing it and how they're doing it. I don't think you can just turn a microphone over to just anybody. There are a lot of radio stations out there will tell you there was a podcasting, I think in New Jersey, got a \$34 million dollar fine for making a racial Islamic comment. It was in the background, they were doing the podcast and a person came behind them and made a racial comment about Islam. Those are things that we've got to be careful of.
- Another thing is, I'm a firm believer that you don't bite the hand that feeds you.




